### What will you Learn?

The workshop will provide active LEPC members with an understanding of the state requirements for LEPC grant funding; including a review of the documentation and forms required to submit to the KY Emergency Response Commission (KERC). The course also provides emergency planners and managers with an understanding of the federal Emergency Planning and Community Right-to-Know Act (EPCRA) and state requirements for EHS Facility Emergency Response Plans (formerly TAB Q-7s). The new WebEOC LEPC dashboard will also be discussed.
